First Take

Nonfarm payrolls rose by 339,000 in May, far exceeding expectations for a slowdown in net job growth last month. Gains were widespread but were largest in government, professional/business services and healthcare. Moreover, revisions to the prior two months added another 93,000 jobs to the March and April counts. Data from the household survey were not as sanguine—the unemployment rate rose 0.3 ppts to 3.7% as the number of people unemployed rose and household employment fell.
